### **SECTION 5. FIRE-FIGHTING MEASURES**

#### **Extinguishing Media**

### Suitable Extinguishing Media

Use water to keep non-leaking, fire-exposed containers cool. Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog.

### **Specific Hazards Arising from the Product**

May accumulate in hazardous amounts at ceilings and at the top of confined spaces, resulting in a health hazard. Closed containers may rupture violently when heated releasing contents.

### Personal Precautions, Protective Equipment, and Emergency Procedures
